Zimmerman-Oster's comments:</p> <ul style="list-style-type: none">- The Lessons Learned & Recommendations and Draft sent this morning contained everything received from the co-chairs.- Any changes made today need to be sent to her as soon as possible so they can be incorporated into a revised draft for Wednesday's PC meeting.- There are two approaches to writing the recommendations, i.e., the chapter filter approach that leads to the recommendation versus the broad information approach in which the recommendations just pop out. <p>SC comments:</p> <ul style="list-style-type: none">- All documents need to be dated.- Lessons learned are not statement of facts as stated in the text but overview summary statements.- Criterion Four lessons learned and recommendations were short and succinct based on the model.- There should be a summary of lessons learned at the end of each chapter. <p>K. Zimmerman-Oster noted that recommendations need to come from the lessons learned.</p> <p>There was a comprehensive discussion of the Criteria Lessons Learned & Recommendations. All of the lessons learned and recommendations were reviewed with specific suggestions made regarding language, consolidation and eliminating redundancies.</p> <p>During the Criterion Three discussion, concerns were raised about the major gap in the Self-Study caused by the lack of a Strategic Plan. The Strategic Plan needs to address 5 major areas: enrollment, technology, resources, faculty development and student life. It was recommended that the SC representatives should expressed this concern at Wednesday's PC meeting.</p> <p>In addition to K.
