# Free legal guidance offered to veterans

Veterans wanting information or help with federal disability and pension benefits can get free legal assistance this Friday and Saturday.

The University of Detroit Mercy School of Law launched the second year of its Mobile Law Office. One of its projects, Project Salute, has helped thousands of veterans with benefits.

Volunteer attorneys and university law faculty and students from the Michigan law school assisted more than 2,000 people during the past year. The mobile office has made numerous stops at regional senior centers, churches and other facilities where veterans congregate.

Staff will be available from 10 a.m. to 4 p.m. both days at the Corpus Christi Northwest Public Library at 3202 McKinzie Road.
