For this academic reporting year, 2023-2024 Outcomes 3 and 4 of the five outcomes were assessed. Every semester, the faculty considers how student competencies were met through academic progression and completion in courses and between levels in the program, with a benchmark of 80% of students progressing from level to level. Students are graded on a competency scale (Competent-Developing-Not Met) in clinical courses where they complete clinical packets and are assessed with a course evaluation tool by the instructor. To earn a Passing grade in clinical the student must be considered Competent. Didactic courses utilize a letter grade (MSON graduate grading scale requires 80% or better to pass, >93% = A, 90-92 = A-, 87-89 = B+, 83-86 = B, 80-82 = B-, 77-79 = C+, 73-76 = C, 70-72 = D, and <69 = F).

For both outcomes, Students collaborated with a health system in which they were providing nursing care to complete clinical practicums and create capstone projects.

Student Learning Outcome 3: MSN candidates will integrate informatics, health care technology, and interpersonal collaboration in the delivery of person--centered nursing practice for individuals and populations.

The benchmark for this outcome is to receive a grade of "Pass" in clinical by demonstrating a competency level considered in all clinical courses (NUR 5137, 5237, 5336, 5338, 5436, 5438, and 5536). Assignments include the clinical packet with compass and reflection as well as assessment of student performance on the clinical evaluation tool by an instructor. Clinical integration hours in NUR 5536 run concurrent to the capstone project in NUR 5055. Students work with a preceptor and a clinical faculty using technology such as the Virtual Nurse and the electronic health record to integrate systems leadership and safe nursing practices into holistic, compassionate patient care that meet the end of program outcomes.

Student Learning Outcome 4: MSN candidates will engage in systems leadership with a focus on preventive care, policy development, and patient advocacy



This benchmark is measured in NUR 5055 on a grading scale where 80% or more is expected to pass the assignment and course. The assessment includes completing and presenting their capstone projects to nursing staff and administration in a public setting, demonstrating the ability to effectively articulate the problem, supporting evidence, process improvements, and expected outcomes. In HLH 5700, the benchmark is to earn a grade 80% or more on the policy brief and analysis signature assignments.

7. **Results, Planned Actions, and/or Actions Taken** -Briefly summarize the assessment results, how they relate to benchmark(s), and how you are using them to enhance student learning and improve program quality.

For the period of reporting, all October 2022 and June 2023 100% of 30 graduates successfully presented their capstone projects, 30/30 earned an A grade and completed clinical integration with a Passing/Competent grade. These 30 students also achieved a grade of A on health policy brief and analysis signature assignments.

Utilizing feedback from our health system partner and students engaged in the project work, a more structured environment to work on projects while at the facility was developed. The result was a rich collaboration with higher quality projects for the June 2023 graduates. Additionally, the faculty and academic partners determined additional time needed to be spent on the projects and the overall program was increased to 10 weeks.
