The Doctoral Program in Clinical Psychology has five learning outcomes which are evaluated annually. Assessment tools include the program's comprehensive examination, external practicum supervisors' evaluation of student performance, and class grades. The program director conducts the assessment and shares results with the University Assessment Team.

1. Students will demonstrate competence in conducting and evaluating psychological assessment, including selecting appropriate assessment methods, interpreting results, and communicating findings effectively.
  - a. Assessment competence will be measured through a passing grade on the Assessment Comprehensive exam. The benchmark for success is 90% of students passing the Assessment Comprehensive exam.
  - i. In AY 2023-2024, there were six doctoral students who took Comprehensive exams. 100% of students received a grade of PASS for the Assessment Comprehensive exam.
2. Students will demonstrate competence in implementing evidence-based psychological interventions, including developing treatment plans, implementing interventions, and evaluating intervention effectiveness.
  - a. Intervention competence will be measured through Supervisor ratings of "meets expectations" or higher on Intervention sections of the Practicum Evaluation Form for External Practicum (PYC 7530). The benchmark for success is 90% of students receiving a rating of "meets expectations" or better.
  - i. In AY 2023-2024 there were 15 doctoral students on practicum. 100% of students meet the criteria of Supervisor ratings of "meets expectations" or higher on Intervention sections of the Practicum Evaluation Form for External Practicum (PYC 7530).
3. Students will demonstrate competence in individual and cultural diversity, including awareness of personal biases, knowledge of diversity research, and ability to work effectively with diverse populations.
  - a. The Diversity competence will be measured through Supervisor ratings of "meets expectations" or higher on Individual and Cultural Diversity sections of the Practicum Evaluation Form (PYC 7530). The benchmark for success is 90% of students receiving a rating of "meets expectations" or better.



i. In AY 2023-2024 there were 15 doctoral students on practicum. 100% of students meet the criteria of Supervisor ratings of "meets expectations" or higher on Individual and Cultural Diversity sections of the Practicum Evaluation Form for External Practicum (PYC 7530).

4. Students will demonstrate competence in psychoanalytic theory, assessment, intervention, and research, including the ability to identify and utilize concepts such as personality functioning, psychological defenses, and transference.

a. The Psychoanalytic competence will be measured through a grade of B or better in Psychotherapy Practicum (PYC 7500). The benchmark for success is 90% of students receiving a grade of B or better..

i. In AY 2023-2024 15 students took Psychotherapy Practicum (PYC7500). 1005 completed Psychotherapy Practicum (PYC7500) with a grade of B or better.

5. Students will demonstrate competence in research methods, including critical evaluation of literature, application of statistical techniques, and design and execution of original research.

a. The Research competence will be measured through the successful completion and defense of dissertation. The benchmark for success is 90% of students receiving a rating of “meets expectations” or better successfully completing the dissertation.

i. In AY 2023-2024 9 students attempted and successfully defended their dissertations (100%).
